The 8th International Conference on Children's Bone Health will be held 10-13 June 2017 in Würzburg, Germany. The aim of this Conference is to bring together upwards of 400 scientists and clinicians from a range of disciplines and from across the globe to gain a better understanding of the growing skeleton in health and disease.

The International Conference on Children's Bone Health (ICCBH) was started in 1999 by an international group of independent clinicians and researchers interested in bone metabolism and bone mass in children, adolescents, and young adults. Five conferences were organised successfully by members of the Organising Committee, the last being in Cambridge, UK, in 2009. Since 2011 the European Calcified Tissue Society manages the conferences on a professional basis on our behalf.

EXHIBITION

Amendments to exhibition layout

Maximum stand height

The maximum height for any part of any stand will be 3.50 m from the ground. Shell scheme stands are 2.00m high.

Disruption to other exhibits

The Organisers reserve the right to restrict exhibits, which, because of noise, method of operation, materials or any other reason, become objectionable to other exhibitors or to delegates. No microphones or loud speakers are to be used on the exhibition floor.

Give-aways and distribution of printed materials

Give-aways and printed material may only be distributed in the space rented by the exhibitor in the exhibition hall, in hospitality suites, or at satellite symposia. No such material may be distributed in any hotel used by the meeting. Product identification is permitted on give-aways. Contests, lotteries and raffles are subject to approval by the Organisers.
